Certain private entities / consultants/ operators are soliciting various manufacturers/ sellers/vendors, by misrepresenting themselves to be authorized agents of GS1 INDIA.

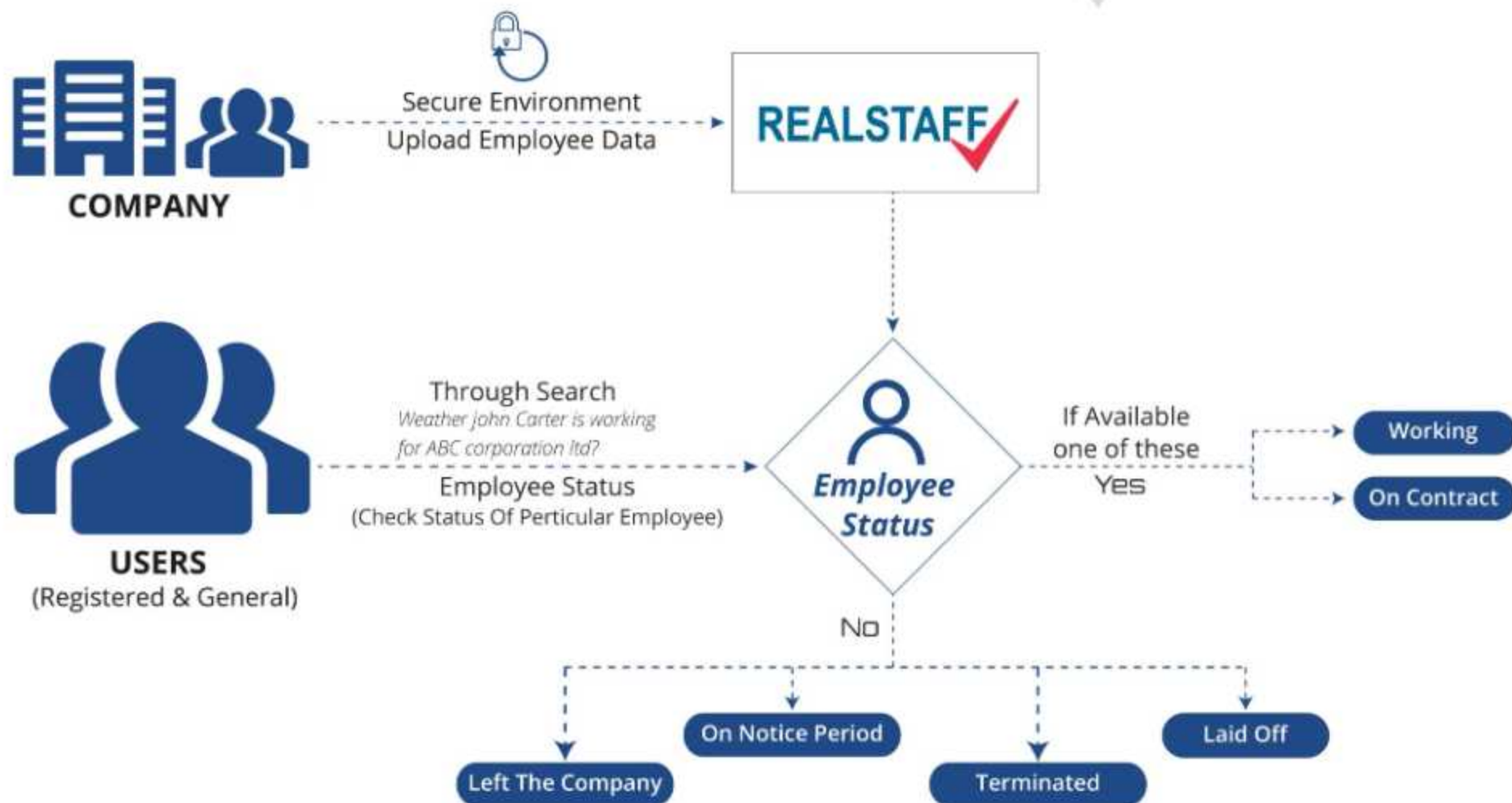
